

### TIME TO GET YOUR BUBBLES ON!!

Please read this entire guide as it will give you the info needed to have an extremely fun day of bubble insanity!

WHEN: 10:00 AM Saturday, Sept. 21st

Arrive between 8:30 -9:00 AM to get your shirt, bib and enter the bubble park. There is no pre-packet pick up before the event, so you will want to make sure that you are able to get your shirt and race bib and have plenty of time to stretch, zumba and prepare to do battle with a bubbly rainbow!

Zumba is at 9:30 AM at the start line! Yeah!

You must preregister online. You will immediately be emailed a ticket that has a QR code on it needed to enter the event when you register online. Print out your ticket and bring it to the event. If you have already registered and do not have your ticket, log into pulsemob.com and resend yourself your ticket.

If you purchased a Groupon, Living Social, ZOZI or any daily deal, you must register online at <a href="https://www.bubblepalooza.com">www.bubblepalooza.com</a>. If you show up at the event without a ticket coming directly from us, you will have to wait in longer line, sign a waiver, pay the \$5 insurance and foam contribution that everyone else already paid and register for the event. Please make sure all of your friends and family have preregistered.

### **SAFETY**

Please make sure that all small children are holding the hand of an adult when passing through the bubble stations. The bubble stations can have immense piles of bubbles stacked up and we don't want anyone to get lost in the bubbles.

There are plenty of bubbles available at the Bubble Bash so please **DO NOT LAY DOWN IN THE BUBBLE STATIONS.** 

If you drop something in the bubbles, please do not stop to look for it. Get a volunteer to find your item.

At the Bubble Bash we have three Epic Yeti Machines. Please only go under the machines in one direction. Do not go backwards under the machines.

# DO YOU NEED TO BRING A SIGNED WAIVER?

- If you preregistered online, then you have already signed a waiver and do not need to bring one.
- If you are bringing a minor under the age of 7 who is not registered, then you need to bring a signed waiver for them. It is at the bottom of this event guide. **CHILDREN 7 & UNDER ARE FREE BUT DO NOT RECEIVE A BIB OR T-SHIRT**. Kid's t-shirts will be available for purchase.
- If you have not pre-registered, then you will need to sign a waiver and bring it with you. The waiver is attached to the bottom of this event guide.

# WHAT SHOULD YOU BRING?

- **A Bandanna.** As you pass through the bubble stations you may want to have something to wipe the bubbles out of your eyes. The little ones may want to wear goggles when they play at the Bubble Bash.
- **A Zip-lock Bag.** Depending how much time you spend popping bubbles at the Bubble Bash, you may end up a little wet. Putting your phone, money and car keys in a Zip-lock is great way to keep things dry.
- **Rubber Bands.** If you twist your white shirt into a knot and then wrap rubber bands around it, you will be able to create a tie dye look on your t-shirt!



- A Trash Bag. If you spend a lot of time playing in the bubbles at the Bubble Bash, you may end up pretty wet and full of color! To make sure that you don't stain your car seat on the way home, you may want to put down a trash bag and bring a towel to dry off with. Please leave the trash bag and towel in your car.
- Money. There will be food vendors and Bubble Palooza gear available for purchase.

### HOW MANY WATER STATIONS WILL THERE BE?

There are two water stations along the three mile course, one at the half way point and one at the end of the event. If you feel that you need more water, please bring a water bottle with you.

# CAN I BRING A STROLLER ONTO THE COURSE?

Yes, you can bring a stroller onto the course. Bigger wheeled strollers work best, as the course will not be on asphalt or concrete due to the coloring of the bubbles. If it rains the day of the event, there may be some obstacles you might have to maneuver around. The colored bubbles may stain your stroller.

# WILL THE COLORED BUBBLES STAIN MY SKIN?

The colored bubbles are created with food coloring. The rainbow bubbles might stain your skin for a little while, but after a shower or a few baby wipes you should look good as new!
